## GENERAL INFORMATION

A non-refundable \$20 Jurying Processing Fee is required with the application form.

APPLICATION WILL NOT BE CONSIDERED WITHOUT JURYING PROCESSING FEE.

***If chosen by the selection committee, Wine in the Woods invitations will be issued in LATE MARCH.***

***You will be notified of acceptance, wait list, or non-acceptance for Holiday Mart and your score by late April, 2009.***

Upon acceptance to a show, you will be required by Maryland law to provide a permanent or temporary sales tax ID number. *For Maryland state tax information: call 410-767-1543 or 1544.*

A temporary Health Department License will be required for any vendor selling food items at any/or all of our shows. **You are responsible for contacting the Health Department at 410-313-2642 to obtain a license at least four weeks prior to the event.**

**Limited electricity** will be provided at **Holiday Mart** based on the postmarked date of individual applications and the **fee will be collected at the show. Electricity will not be available at Wine in the Woods.**

- \*No tables, canopies, or chairs will be provided.
- \*Vendors may not switch, sublet, or apportion spaces to other vendors.
- \*Vendors **must** keep booths open for **ENTIRE** show.
- \*Vendors can **ONLY** sell categories that were registered and juried.

## RECREATION & PARKS

reserves the right to request an inventory of items to be sold by vendor and to disallow any entry, based on the guidelines and the decisions of the screening committee.

Failure to comply with regulations will result in vendor being prohibited from participation in future Howard County Recreation & Parks craft shows.

### Acceptable Categories

- \*Apparel \*Jewelry \*Photography
- \*Wood \*Baskets \*Leather \*Plants
- \*Ceramics \*Pottery/Clay \*Fabric \*Glass
- \*Mixed Media \*Soft Sculpture \*Floral
- \*Needlework \*Paintings/Drawings
- \* Jewelry that is the product of the vendor (no agents)\*Mixture of categories (two or more)

### Selection Criteria

- \*Originality \*Uniqueness \*Display
- \*Attractiveness \*Quality \*Popularity
- \*Balance of crafts (type)

---

### Types of Crafts Allowed

Original, handcrafted art and craft items; **must be product of the vendor** and must be **representative of the items juried.**

---

### Types of Crafts NOT allowed

- \*Kits and commercially manufactured
- \*merchandise
- \*Imported merchandise
- \*Novelty sales items
- \*Sports Collectibles

## Application Guidelines:

- Three to five current, high-quality photographs/CD of your craft and one of your display** (display photo *will be retained* with application) must accompany application form. **NO POLAROID!** If a self-addressed business size envelope with sufficient postage is enclosed, photographs/CD will be returned in April.
- Only crafts in the categories juried may be sold at the shows.**
- A **non-refundable \$20.00** jurying/processing fee must accompany the application. Do **not** send your **space fee** until you have been notified of acceptance.

### **BEFORE MAILING, have you enclosed**

- ✓ Jurying application?
- ✓ Three to five /photographs/ digital photos on disc **(no Polaroids)?**
- ✓ **Mandatory non-returnable photo of your display?**
- ✓ Self-addressed stamped envelope to return jurying photographs/discs?
- ✓ A \$20.00 check payable to *Director of Finance, Howard County?*

## Photograph and CD Preparations

### Suggestions:

Begin preparation now! You will need three to five professional quality 35 mm color photographs/CD ready to submit with your application.

Since the jury will be judging your work based on photographs/discs, *please pay special attention to the **quality** that you submit.* The judges cannot imagine what is not there, nor subtract from what is there. **Your photographs/CD are surrogates for your work; therefore, quality is of the utmost importance to you!** The following hints could help you in selecting photographs/CD of the highest quality to submit with your entry:

- Make sure your photographs and digital photos on CD are not too dark, too light, or out of focus and are of professional quality color.**
- Fill the frame with an individual piece rather than groupings.**
- In selecting your photographs/CD, remember that the consistency of your work is important.**
- The background should not be too busy or too textured.**
- Avoid reflection or excessive shadowing on the subject.**
- Avoid distortion of the subject or over dramatic shots.**
- Choose a background color that will enhance the subject. A bright color tends to compete with the subject.**
- Photographs/CD of similar or same backgrounds make a better presentation.**
